MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding has been made and executed at Delhi on the of the October, 2020;

BETWEEN

Gurmat College, a registered organisation Under DSGMC (Statutory Body Estd. Under the Delhi Sikh Gurdwaras Act, 1971 of the Govt. of India) having its registered office at Mata Sundri Gurudwara, Delhi. (hereinafter called the First Party)

AND

Mata Sundri College for Women, incorporated under University of Delhi, in 1967, having its campus at Mata Sundri Lane, New Delhi-110014, through the Principal of the college Prof. Harpreet Kaur (hereinafter called the Second Party)

WHEREAS, the First Party is a registered organisation with Delhi Government, under the Indian Registration Act. (Registration Number) It is a value based educational college.

AND WHEREAS, the Second Party has been a college under the University of Delhi, since 1967, functioning to provide education and to disseminate knowledge in various branches of Social Sciences, Commerce and Humanities.

AND WHEREAS, the Second Party was desirous of conducting an online course on inculcating Social and Moral Values through Guru Granth Sahib, to steer the young adults through these challenging and stressful times. And whereas, the proposal of the Second Party, regarding the need of the hour, has been accepted by the First Party. The First Party, as such, agrees to start a Thirty hours' course in this subject of utmost importance. The duration of this MoU will be one year from the date of signing by both the parties.

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned herein, in order to conduct an online Thirty hours' course including Learning and Assessment on Philosophical Practices. It will be a holistic Social, Moral and Philosophical Counselling of the youth.

1. The First party will design a Thirty hours' online course, titled GURU MANIYO GRANTH pertaining to value enhancement of youth, with concurrence of Second Party.
2. The Course will begin with new admissions in November 2020 and it will be open for students of all semesters, from all disciplines including students from other colleges.
3. The Course details/content/structure will be circulated through web portal and social media platforms of both parties to secure students' participation on a large scale in this course.
4. This course will be a Value Based Skill Enhancement course which will aim to improve life skills as well as professional skills of students.
5. First party S. Harinderpal Singh, Chairman, Gurmat College, will be the Chief Mentor of this aforesaid Course. His services shall be honorary and he will **NOT** be entitled to any salary, allowances or perquisites.
6. The course instructors will **NOT** be an employee of the Second Party. **NEITHER** will he get any appointment letter from the Second Party **NOR** will he be entitled to any salary, allowances or perquisites from the Second Party.
7. Certificates to Issue on behalf of both the Parties.
8. Second party will charge and collect One hundred rupees as registration fee from each participant for this course and total generated funds through registrations will be given to Resource Person as honorarium.

HEREINAFTER, both parties have agreed to discharge following responsibilities:

First Party:

- To design the course
- To appoint an instructor
- Teaching and assessment
- To issue certificates on behalf of both Parties.
