



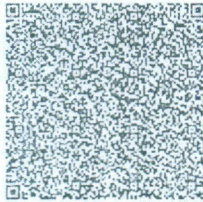

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered on 18<sup>th</sup> February, 2021 at New Delhi, India, Between

The Mata Sundri College for Women, India having its office at Mata Sundri Lane, Mandi House, New Delhi, Delhi 110002, India (herein referred to as "MSCW") on the one part represented by **Dr. Harpreet Kaur (Principal)**.

And

The Sri Guru Nanak Dev Khalsa College, India having its office at Guru Ravi Das Marg, Block 4, Dev Nagar, Karol Bagh, New Delhi, Delhi 110005, India (herein referred to as "SGNDKC") on the one part represented by **Dr. Gurmohinder Singh (Principal)**.

MSCW and SGNDKC wish to enter an agreement for jointly designing and executing a short-term Certificate course on "**HOLISTIC FITNESS AND WELLNESS LEARNING**" for Indian university students as per the following:

1. **MSCW** and **SGNDKC** will jointly design the course to be given in the form of online sessions, assignments and review tests.
2. **MSCW** will provide the technical support for the short-term certificate course which will be payable @ INR 2000/- for full course.
3. **MSCW** will provide the online platform (Zoom) for the short-term certificate course. The expenses on subscription of the same will be equally shared by MSCW and SGNDKC.
4. The course will be of 30 hours duration and will be covered over a period of 4 weeks and/or 1 month.
5. One batch would consist of not less than 60 students; the onus of marketing the course would be on **MSCW** and **SGNDKC** jointly.
6. Participation fees will be INR 300/- per student, which will be collected through PayU app with the **MSCW**.
7. The expenditure on the full course will be equally shared by **MSCW** and **SGNDKC**.
8. Honorarium for speaker is fixed at INR1500/per session of 1&1/2 hour.
9. **MSCW** will deduct the incurred expenses and TDS on the amount, as applicable, while transferring the fees.
10. **MSCW** will provide the Account handling support for the short-term certificate course which will be payable @ INR 1000/- for full course.
11. **MSCW** and **SGNDKC** will jointly execute the course & evaluate the assignments as well as the review tests.
12. **MSCW** and **SGNDKC** will jointly design an e-certificate to be given to successful candidates.
13. Thus, MOU is specific for this short-term certificate course only.
14. In case of any dispute or difference whatsoever arising between the parties out of relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. "However, the court of jurisdiction would be New Delhi."

This MoU will remain valid for Three months from the date of signing.
