#### MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding has been made and executed at Delhi on the 2<sup>nd</sup> of November, 2020

### **BETWEEN**

Meghnad Desai Academy of Economics, a registered organisation Under Spring IVY Educational Services LLP (registration No.) having its registered office at World Trade Centre (Hereinafter called the First Party) AND

Mata Sundri College for Women, incorporated under University of Delhi, in 1967, having its campus at Mata Sundri Lane, New Delhi-110014, through the Principal of the college Prof. Harpreet Kaur (hereinafter called the Second Party)

WHEREAS, the First Party is a registered organisation with Spring IVY Educational Services LLP, under the Indian Registration Act. (Registration Number) It is a value based educational college. AND WHEREAS, the Second Party has been a college under the University of Delhi, since 1967, functioning to provide education and to disseminate knowledge in various branches of Social Sciences, Commerce and Humanities. AND WHEREAS, the Second Party was desirous of conducting an online national workshop on the basic framework of researching on contemporary economic issues in Indian economics with special focus on India's middle class to provide the young adults to a framework to explore research ideas. And whereas, the proposal of the Second Party, regarding the need of the hour, has been accepted by the First Party. The First Party, as such, agrees to conduct a national workshop. The duration of this MoU will be for two days that is 6<sup>th</sup> and 7<sup>th</sup> of November

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned herein, in order to conduct an online national workshop on research ideas in economics. It intends to provide a basic research aptitude which will help the students in their carriers by enhancing their research skill.

- The First party will design a two day online national workshop, titled A TWO DAY NATIONAL WORKSHOP RESEARCHING ON DYNAMIC ECONOMIC ISSUES: SPECIAL FOCUS ON INDIA'S MIDDLE CLASS dealing with research framework and assignments for skill enhancement
- 2. The national workshop will be held on  $6^{th}$  and  $7^{th}$  of November 2020 and it will be open for students of all semesters, from all disciplines including students from other colleges.
- 3. The Course details/content/structure will be circulated through web portal and social media platforms of both parties to secure students' participation on a large scale in this course.
- 4. This national workshop will be a Value Based Skill Enhancement national workshop which will aim to improve life skills as well as professional skills of students.

- 5. First party Dr. Sandhya Krishnan will be the Chief Mentor of this aforesaid National Workshop. She will be paid an honorarium. The course instructors will NOT be an employee of the Second Party. NEITHER will he get any appointment letter from the Second Party NOR will he be entitled to any salary, allowances or perquisites from the Second
  - 7. Certificates will be issued on behalf of both the Parties.
  - 8. Second party will not charge any fee for registration fee from the participants. The second party will pay the fees to the resource person and first party will provide its services to the participants.

HEREINAFTER, both parties have agreed to discharge following responsibilities: First Party:

- To design the course
- To appoint an instructor
- Teaching and assessment
- To issue certificates on behalf of both the Parties.

## Second party

- To pay the fee to the resource person
- To organise the event

HEREBY, the aforementioned parties have agreed to establish the relation by accepting the mentioned tasks for this MOU.

PROVIDED THAT signing of this MOU is not a formal undertaking, it implies that the signatories will strive to reach, to the best of their ability, the objectives stated in the MOU.
