



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered on 17 August 2021 at New Delhi, India,
Between

The Mata Sundri College for Women India, having its office at Mata Sundri Lane, Mandi House, New Delhi, Delhi-110002, India (herein referred to as "MSCW") on the one part represented by **Dr. Harpreet Kaur (Principal)**

And

The Millat News Network Private Limited, M 52, Fourth Floor, Batla House, Near Chinar Apartment, Khalulullah Masjid, New Delhi, Delhi-110025 (herein referred as "MNNPL" on the other part represented by **Shams Tabrez Qasmi (Founder & Chief Director)**. [Corporate ID No. – U74999DL2018PTC333179]

MSCW and MNNPL wish to enter an agreement for jointly designing and executing a short term Certificate course on "**Elementary Urdu**" as per the following:

1. MSCW and MNNPL will jointly design the course, based on initial inputs from MSCW to be given in the form of online sessions, assignments and review tests.
2. MSCW will provide all the technical support/ online platform (MS-Team/Zoom etc.) for the short term certificate course on "**Elementary Urdu**".
3. The course will be of 30 hours duration and will be covered over a period of 4 weeks and/or 1 month.
4. Fees will be directly collected by MSCW and will be transferred to Bank Account of MNNPL.
5. Participation fees will be INR 200/- per student, out of which 100% will be transferred to MNNPL.
6. MNNPL will provide an invoice along with the course completion certificate.
7. MNNPL will execute the course and will evaluate the assignments as well as the review tests.
8. MSCW and MNNPL will jointly design an e-certificate to be given to successful candidates.
9. In case of any dispute or difference whatsoever arising between the parties out of relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach there of shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. "However, the court of jurisdiction would be New Delhi."

This MoU will remain valid for one year from the date of signing.


