MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered on 9th August, 2021 at New Delhi, India,
Between

The Mata Sundri College for Women India, having its office at Mata Sundri Lane, Mandi House, New Delhi, Delhi 110002, India (herein referred to as "MSCW") on the one part represented by **Dr. Harpreet Kaur (Principal)**

And

The Society for Environment & Sustainable Development, LIG Flat, Pocket-C, Molarbandh, New Delhi-110044, (herein referred as "SESD") on the other part represented by **Dr. Sanjay Marale (President)**. [Reg. No. S-E/1562/Dist. South East 2019]

MSCW and SESD wish to enter an agreement for jointly designing and executing a short term Certificate course on "**Environment Management**" as per the following:

1. MSCW and SESD will jointly design the course, based on initial inputs from SESD, to be given in the form of online sessions, assignments and review tests.
2. SESD will provide all the technical support/ online platform (MS-Team/Zoom etc.) for the short term certificate course on "**Environment Management**".
3. The course will be of 30 hours duration and will be covered over a period of 6 weeks and/or 1 month.
4. Fees will be directly collected by MSCW and will be transferred to Bank Account of SESD.
5. MSCW will transfer Rs. 30,000/- plus GST, to SESD and deduct 10% TDS on the amount, as applicable, while transferring the fees.
6. MSCW will transfer the fees after the successful completion of the course.
7. SESD will provide an invoice along with the course completion certificate.
8. SESD will execute the course & evaluate the assignments as well as the review tests.
9. MSCW and SESD will jointly design an e-certificate to be given to successful candidates.
10. In case of any dispute or difference whatsoever arising between the parties out of relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach there of shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. "However, the court of jurisdiction would be New Delhi."

This MoU will remain valid for one year from the date of signing.
