MEMORANDUM OF UNDERSTANDING (MoU)


This Memorandum of Understanding (MoU) is made on AUGUST.....10.....2020 between **Department of Computer Science, Mata Sundri College for Women, University of Delhi, located at Mata Sundri Lane, New Delhi (Herein after called the 'First Party')**

And

Teaching Learning Centre (TLC) of Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 (Herein after called the 'Second Party').

And whereas the *First Party* and the *Second Party* have agreed to the following terms and conditions of the agreement:

1. The aim of the hereby agreement is to enhance the capacity building of teachers/faculty members through organizing Online Faculty Development Programme on ICT BASED NEW PARADIGMS OF E-TEACHING AND E-LEARNING: DIGITAL PEDAGOGY in September-October 2020.
2. The Provisions provided by "First Party i. e Department of Computer Science, Mata Sundri College for Women, University of Delhi, located at Mata Sundri Lane, New Delhi are given as under:-
 - a. Arrangement of resource persons
 - b. Producing video contents for external resource persons
 - c. Producing written contents for external resource persons
 - d. Drafting quizzes and assignments for external resource persons
 - e. Evaluating assignments for external resource persons
 - f. Payment to organizing team of the first party
 - g. Collection of registration fees
 - h. Administrative support in terms of organizers



- i. Preparation of reports for each session
- j. Overall Cooperation

3. The Provisions provided by "Second Party i. e. Teaching Learning Centre of Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 are given as under:-

- a. Providing portal for conduct of FDP
- b. Maintenance of portal
- c. Payment to Resource Persons
- d. Administrative support in terms of organizers
- e. Participation certificate
- f. Consultancy to conduct the FDP
- g. Technical inputs regarding Sessions and Modules
- h. Overall Cooperation

4. Registration fee of Rs 750/- will be charged from the participants through NEFT/Online Mode/UPI and will be used to meet the expenses for the said FDP. The collection of the registration fee will be done by the First Party. The faculty members of the first party participating in the FDP will be paying the full FDP registration amount.
