MEMORANDUM OF UNDERSTANDING

BETWEEN

Mata Sundri College for Women (hereafter "MSC")

AND

GirlScript Foundation (U74999MH2017NPL295682) of Nagpur, MH- 440027
(hereafter "GS")

This Agreement made and entered into on the 21th day of January 2022 between MSC and GS.

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

i) To provide a formal basis for initiating interaction between MSC and GS in mutually beneficial areas such as:

Deliverables from GS: -

- Promotion of MSC as **OUTREACH PARTNER** through all social media handles.
- Invitation to be one of the dignitaries from the college for a special session.
- ₹100 per student registered for the welfare and development of MSC (**IFF** the count of students for **Short Term Course on "Graphics Designing & Web Development" (STC)** is 30 or more than 30). The detailed proposal of the STC is separately enclosed with this document. MSC Principal Signature and MSC Logo on the Certificates.
- Assessment Exam to be conducted at the end of **STC**
- Results Report Card of Students for the Assessment Exam
- Issue of Course Completion Certificate for Students and Certificate of Appreciation to MSC Programme Coordinators within 10 days of **STC** Completion

- To stop the spread of the Covid pandemic, all sessions will be conducted Online.

Expectations from MSC: -

- Promotion of GIRLSRIPT and **STC** through official social media handles.
- Promotion of **STC** within MSC, all associated colleges, branches, sections, streams and years.
 - The STC cost will be **Rs 1,600 per head**
 - The STC will be for **30 hours** from **21th January 2022** to **31st January 2022**
 - The STC will be conducted from 6 pm to 8 pm on weekdays and from 4 pm to 8 pm on weekends
- MSC needs to pay the total amount in two instalments:
 1. 50% amount advance before 28th January 2022
 2. 50% amount after certificate release before 10th February 2022
- MSC needs to share the complete information of students with GS and based on that, GS will share the amount 100rs/participant for above 30+ students.

2. PROPOSED MODES OF COLLABORATION

MSC and GS propose to collaborate through each of the above modes of interaction, which will be initiated by entering into a separate agreement between the two parties.

3. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire after 24 hours of signing. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 1 week prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Research Agreement, Confidentiality clause as referenced in clause 6 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such terminate.

4. RELATIONSHIP

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.
