## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is entered on 24 December 2020 at New Delhi, India,  
Between

The Mata Sundri College for Women India, having its office at Mata Sundri Lane, Mandi House, New Delhi, Delhi 110002, India (herein referred to as "MSCW") on the one part represented by **Dr. Harpreet Kaur (Principal)**

And

The WISE Foundation India, having its office at B-71, Sector-52, Noida-201301, UP, India (herein referred to as "WISE") on the other part represented by **Anshul Jain. (GST No 09ALOPJ2878C1ZT)**

And

Danish Water Forum, having its office at Agern Alle 5, DK-2970, Horsholm, Denmark (herein referred to as "DWF") on the other part represented by **Anshul Jain (Head-Asia Pacific- DWF) (CVR No 27007597)**

MSCW and WISE and DWF wish to enter an agreement for jointly designing and executing a short term Certificate course on "**Environment and Sustainability**" for Indian university students as per the following:

1. MSCW and WISE and DWF will jointly design the course, based on initial inputs from WISE and DWF, to be given in the form of online sessions, assignments and review tests.
2. WISE and DWF will provide all the technical support/ online platform (MS-Team/Zoom etc.) for the short term certificate course.
3. The course will be of 30 hours duration and will be covered over a period of 4 weeks and/or 1 month.
4. One batch would consist of not less than 100 students; the onus of marketing the course would be on MSCW.
5. Participation fees will be INR 750/- per student, out of which INR 150 (20%) will be kept by MSCW and remaining INR 600 (80%) will be shared with WISE (representing DWF financially in India).
6. Fees will be directly collected by MSCW and will be transferred to WISE.
7. MSCW will deduct TDS on the amount, as applicable, while transferring the fees.
8. MSCW will transfer the full fees within 10 days of completion of the course.
9. WISE and DWF will provide an invoice along with the course completion certificate.
10. WISE and DWF will execute the course & evaluate the assignments as well as the review tests.
11. MSCW and WISE and DWF will jointly design an e-certificate to be given to successful candidates.
12. In case of any dispute or difference whatsoever arising between the parties out of relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach there of shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. "However, the court of jurisdiction would be New Delhi."

This MoU will remain valid for one year from the date of signing.
