

# MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding has been made and executed at Delhi on the 13th of the October, 2020;

## BETWEEN

**Lifeworld Foundation**, a registered NGO (Reg. No. 1372) having its registered office at Delhi, through its Founder / Managing Trustee Mr. Abhishek Shukla (hereinafter called the party of the First Part or the First Party);

## AND

**Mata Sundari College**, incorporated under University of Delhi, 1967 having its campus at New Delhi, Delhi, through the principal of the college Dr. Harpreet Kaur (hereinafter called the Party of the Second Part or the Second Party).

WHEREAS, the first party is a NGO in Delhi since 2020, registered by the Delhi Government, under the Indian Registration Act. The first party is an educational and charitable Trust working towards establishing Philosophical Practise as a profession in India.

AND WHEREAS, the party of the second half has been a college under the University of Delhi, 1967 to provide education in various branches of Sciences and Arts and to disseminate knowledge in these branches.

AND WHEREAS, the Second Party was desirous of conducting an online course on Philosophical Practice (Philosophical Counselling) to cater the needs of the students. And whereas, the proposal of the Second Party has been accepted by the First Party. The First Party, as such, agrees to start a course on Philosophical Counselling for thirty hours duration and duration of this MoU will be one year.

**NOW THEREFORE**, the aforementioned parties have agreed to the terms and conditions as mentioned hereinafter in order to conduct an online thirty hours course including practical and assessment on Philosophical Practice (Philosophical Counselling);

1. First party will design thirty hours online course on Philosophical Practice (Philosophical Counselling) (hereinafter referred to as course) with concurrence of second party.
2. Course will begin with new admissions in November 2020 and it will be open for students of all semesters from all disciplines including students from other colleges.
3. Course details/content/structure will be circulated through web portal and social media platforms of both parties to secure students participation in this course.
4. This course will be a skill enhancement course which will aim to improve life skills as well as professional skills of students.
5. First party will appoint Mr. Abhishek Shukla instructor for this course. His services for Trust will be unpaid and shall **NOT** be entitled to any salary, allowances or perquisites.

6. Course instructor will **NOT** be an employ of second party. **NEITHER** he will get any appointment letter from second party **NOR** will be entitled to any salary, allowances or perquisites from second party.
7. First party in collaboration with second party will issue certificates to the students after successful completion of course.
8. First party reserves right to appoint teaching assessment for instructor.
9. Second party will charge and collect 200 Rs (two hundred rupees) fee for this course and 70% (seventy percent) of total collection, will be donated to First party.

**HEREINAFTER**, both parties have agreed to discharge following responsibilities:

First party

- To design course
- To appoint instructor
- Teaching and assessment
- To issue certificates

- To give admission
- To charge fee
- To collect fee
- To donate
